Town hall Meetings

Town hall is a virtual meeting with families in LTC and the executive director. The meeting discusses events, policies, changes, ideas and concerns etc. It takes place on the 2nd Tuesday of each month at 3pm and the executive director sends the zoom link to all the families.

Quick recap from last meeting:

Any staff that has a medical exemption to the Covid Vaccine are swabbed daily (currently we have one, not a direct care worker).

- Residents are tested if symptomatic
- Fully Vaccinated Caregivers, staff, general visitors, support workers are all tested with rapid antigen tests once per week. Errinrung is doing our testing on Wednesdays and Thursdays. It will still be required to obtain a weekly negative rapid swab but wait times may be longer on days outside of Wednesday or Thursday.
- You can obtain proof of negative swab if you plan to visit another facility or will be coming back that same day.
- If in outbreak, testing strategies would change based on Public Health recommendations.
- 98% are fully vaccinated
- 2% have a medical exemption
- 97% of Residents
- Vaccine mandate in effect. No staff are hired unless fully vaccinated or have an approved medical exemption to the vaccine. Next meeting is **December 7**th at 3pm.
